NOTICE IS HEREBY GIVEN that the Township Board of the Township of Dalton, Muskegon County, Michigan, has determined to construct road improvements consisting of the paving of East Bard Road from Holton Road to Dalson Road to serve properties located within East Bard Road Improvement Special Assessment District No. 34 (the "District") (the "Improvements"), pursuant to Act 188 of the Public Acts of Michigan of 1954, as amended.

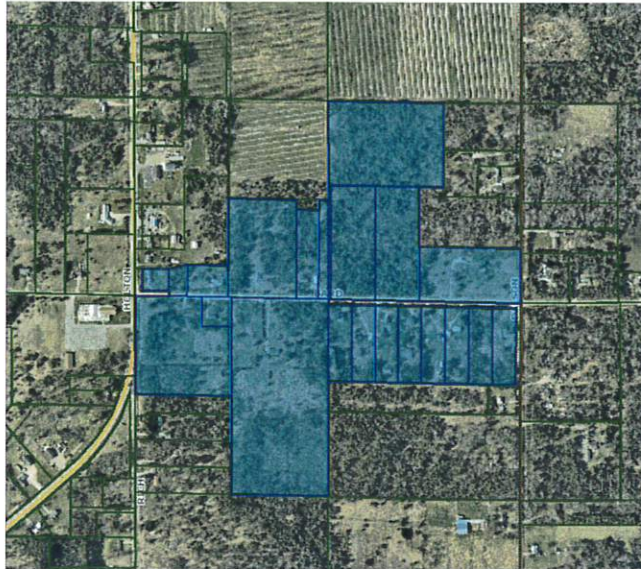

TAKE NOTICE that the Township Board of the Township of Dalton will hold a public hearing at a regular meeting of the Township Board on August 10th, 2026, at 6:00 p.m., or shortly thereafter, at the Dalton Township Hall, 1616 East Riley Thompson Road, Muskegon, MI 49445 within the Township, to hear and consider any objections to the proposed Improvements, the District and all other matters relating to said Improvements and the District.

TAKE FURTHER NOTICE that preliminary plans and estimates of cost for the Improvements are on file with the Township Clerk for public examination.

PROPERTY SHALL NOT BE ADDED TO THE PROPOSED SPECIAL ASSESSMENT DISTRICT AND THE ORIGINAL ESTIMATE OF COST SHALL NOT BE INCREASED BY MORE THAN 10% WITHOUT FURTHER NOTICE AND PUBLIC HEARING.
